ORDER

On November 25, 2014, the Commission issued an Order giving all parties until December 5, 2014, to submit a written statement requesting either that the Public Hearing be conducted on December 17, 2014, as scheduled, or that the matter be submitted to the Commission for a decision based on the existing evidentiary record. The Order required any statement requesting that the Public Hearing be conducted as scheduled to set forth with specificity the issue(s) to be raised and to identify the witness(es) to be cross-examined.

The Order stated that the Public Hearing would be cancelled if no party requested that it be conducted, and that the parties, either individually or jointly, would be allowed to submit a brief on or before February 27, 2015.

Finally, the Commission stated that, in any case, public meetings would be held in Hearing Room 1 at the Commission's offices in Frankfort, Kentucky, on December 16, 2014, at 6:00 p.m. Eastern Standard Time ("EST"), and on December 17, 2014, at 10:00 a.m. EST, for the purpose of taking comments from the public.


On December 3, 2014, the parties to the case filed a joint statement indicating their belief that the matter can be submitted to the Commission for a decision based on the existing evidentiary record without the need for a Public Hearing.

Finding that no party has requested that the Public Hearing be conducted, the Commission will cancel the December 17, 2014 Public Hearing.

IT IS HEREBY ORDERED that:

1. The December 17, 2014 Public Hearing is cancelled.
2. Parties, either individually or jointly, shall have an opportunity to submit a brief, at their option, no later than February 27, 2015.
3. Public meetings shall be held in Hearing Room 1 at the Commission's offices in Frankfort, Kentucky, on December 16, 2014, at 6:00 p.m. EST, and on December 17, 2014, at 10:00 a.m. EST, for the purpose of taking comments from the public.
