


MOTION TO VACATE

Comes the Big Sandy Water District, by counsel, and for its Motion to Vacate the Commission's Order entered September 17, 2012, states as follows:

The Big Sandy Water District did not respond to the motion filed by Overland Development, Inc., and, in retrospect, perhaps should have done so. However, the Commission did not need a response to find *sua sponte* that neither the record nor law supports Overland Development's arguments. The District provided the notice required under the statutes and regulations and the Commission certainly had the authority to make a decision. The Commission's opinion has been made crystal clear in its Order entered September 17, 2012, and it is respectfully contended that there is nothing to be gained by the parties for Overland Development to have a rehearing.

WHEREFORE, for the foregoing, Big Sandy Water District moves the Commission to vacate its Order entered September 17, 2012, and to reject Overland Development's motion for a rehearing.


