ORDER

Complainants have filed a complaint with the Commission in which they allege a dispute with Henry County Water District No. 2 (“Henry District”) over the ownership and maintenance responsibilities of a water service line. On May 22, 2013, the Commission established a procedural schedule in this matter.

On June 3, 2013, Henry District filed a motion to hold the matter in abeyance or to defer the operation of the procedural schedule by 30 days.¹ On June 5, 2013, Complainants filed a response to the motion in which they joined in Henry District’s request. Complainants and Henry District indicate that a settlement has been reached, but that additional time is necessary to prepare and execute a settlement agreement.

Finding that good cause to grant the motion has been shown and being otherwise sufficiently advised, the Commission **HEREBY ORDERS** that:

¹ In its Motion, Henry District specifically requested that the Commission “to enlarge the time to respond by 30 days.” Complainants made a similar request in their Response. We interpret these requests as a request to defer or delay the operation of the established procedural schedule.

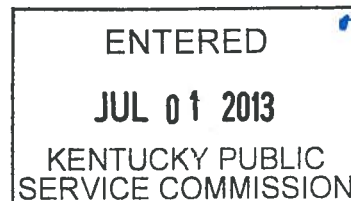
1. Henry District's motion to defer the operation of the procedural schedule is granted.

2. Unless the parties file a settlement agreement by July 15, 2013, the procedural schedule set forth in the Appendix to this Order shall be followed.

3. The hearing previously scheduled in this matter for August 5, 2013 is cancelled and shall be rescheduled at a later date if necessary.

4. The ordering paragraphs 2 through 13 of the Commission's May 22, 2013 Order remain in effect.
