#### ORDER

On March 1, 2013, Columbia Gas of Kentucky, Inc. ("Columbia") filed with this Commission its Accelerated Main Replacement Program ("AMRP") Rider 2013 annual update data, along with proposed increases to AMRP rates for customer classes subject to the rider. On April 10, 2013, Columbia responded to Commission Staff's requests for information. There are no intervenors in this proceeding. The case now stands submitted for decision.

Having reviewed the evidence of record and being otherwise sufficiently advised, the Commission finds that the information contained in Columbia's annual update data, along with its data responses, is in sufficient detail to support the reasonableness of Columbia's proposed AMRP rates. The Commission further finds that in future filings Columbia should continue to include with its annual update data a breakdown of additions to Account 376.25, Mains-AMRP, showing the length of pipe for each size of pipe installed and in sufficient detail to show the makeup of cost of materials, cost of labor, and non-material items. All future applications requesting AMRP rate increases should continue to be filed annually no later than March 1.

#### IT IS HEREBY ORDERED that:

- 1. The AMRP rates in the Appendix to this Order are approved for billing with Columbia's June 2013 billing cycle effective May 30, 2013.
- 2. In every future filing of annual update data and application for increased AMRP rates, Columbia shall continue to file the detailed breakdown of additions to Account 376.25, Mains-AMRP, as required herein.
- 3. Columbia shall file future AMRP rate increase applications annually no later than March 1.
- 4. Within 20 days of the date of this Order, Columbia shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the AMRP rates approved herein and reflecting that they were approved pursuant to this Order.
