ORDER

Henderson County Water District (“Henderson County District”) has advised the Commission of its acceptance of the findings set forth in the Commission Staff Report. Henderson County District requests approval to immediately assess its proposed rates and authorization to impose the Commission Staff’s recommended rates one year later. Henderson County District further requests this case be submitted for a decision based upon the existing record without a hearing.


The Commission, on its own motion, HEREBY ORDERS that:

1. Henderson County District shall publish notice of the revised request in a newspaper of general circulation in its territory no later than September 25, 2013 and shall provide the Commission with proof of publication of such notice no later than October 2, 2013. Notice shall be in the format set forth in the Appendix to this Order.
2. The informal conference scheduled in this matter for September 17, 2013 is cancelled.
3. The hearing in this matter scheduled for October 15, 2013 is cancelled.
4. On October 15, 2013, this case shall stand submitted for a decision.

**NOTICE TO THE CUSTOMERS OF
HENDERSON COUNTY WATER DISTRICT**

On April 18, 2013, Henderson County Water District applied to the Kentucky Public Service Commission ("PSC") for authority to adjust its rates for water service. After performing a review of Henderson County Water District's application and records, the PSC Staff has recommended to the PSC that Henderson County Water District be granted an increase greater than that requested. The table below reflects the originally proposed rates and the PSC Staff-recommended rates:

If the Commission does not receive any objections or requests for intervention or hearing in this matter by October 15, 2013, the Commission shall proceed to render a decision in the matter.
