## ORDER

On October 4, 2013, Kentucky Power Company ("Kentucky Power") filed, pursuant to 807 KAR 5:001, Section 21, for leave to deviate from the filing requirements of the Commission's July 30, 2013 Order. Kentucky Power requests approval to submit a single paper copy and ten copies in an electronic medium to the Commission and to submit copies in an electronic medium to all parties of record of its responses to the Attorney General's ("AG") Initial Data Requests, Item Nos. 4, 8, 10 and 33.

Kentucky Power states that the responses to these data requests encompass 78 documents totaling in excess of 1,800 pages. It further notes that many of the documents are already in electronic format and distributing electronic copies would provide the parties to the case full access to the documents included in the responses to the data requests.

Based on a review of the record and being otherwise sufficiently advised, the Commission finds that Kentucky Power has shown good cause to deviate from the filing requirements of the Commission's July 30, 2013 Order and 807 KAR 5:001, Section 7(1). Our finding is based on the number of pages in Kentucky Power's responses to the enumerated data requests, the fact that the procedural schedule in this case has been suspended by Order entered October 24, 2013, and the pending rate application

may be withdrawn. Kentucky Power is authorized to file an original in paper medium plus ten copies in an electronic medium with the Commission and to serve parties of record with copies in an electronic medium of responses to AG 4, 8, 10, and 33.

IT IS THEREFORE ORDERED that Kentucky Power's motion to deviate from the filing requirements of the Commission's July 30, 2013 Order and 807 KAR 5:001, Section 7(1), is granted to the extent that Kentucky Power may file an original in paper medium plus ten copies in an electronic medium to the Commission, and serve copies in an electronic medium to all parties of record its responses to the data requests identified herein.
