ORDER

On May 22, 2013, Northeast Woodford Water District ("Northeast Woodford") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Northeast Woodford purchases water from the city of Versailles ("Versailles").
- 2. On July 1, 2013, Versailles's wholesale rate to Northeast Woodford increased from \$2.26 per 1,000 gallons to \$2.33 per 1,000 gallons.²
- 3. Northeast Woodford proposes to increase its water rates to its customers effective July 1, 2013.
- 4. During the 12 months ending March 31, 2013, Northeast Woodford purchased a total of 150,131,200 gallons of water and sold 124,579,000 gallons.

- 5. The increase in the cost of purchased water is \$10,509.19, resulting in a purchased water adjustment factor of \$0.08 per 1,000 gallons.
- 6. The purchased water adjustment of \$0.08 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.
- 7. Northeast Woodford's proposed rates, which are set forth in Appendix B, are fair, just and reasonable.

IT IS THEREFORE ORDERED that:

- 1. Northeast Woodford's proposed adjustment of \$0.08 per 1,000 gallons is approved for water service rendered on and after July 1, 2013.
 - 2. Northeast Woodford's proposed rates are approved.
- 3. Northeast Woodford's proposed tariff sheets, which were submitted with its application, are approved as filed.
