ORDER

On June 6, 2013, Judy Water Association ("Judy Water") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Judy Water purchases water from Mount Sterling Water and Sewer Commission ("Mount Sterling") and the city of North Middletown.
- 2. On July 1, 2013, Mount Sterling increased its wholesale rate to Judy Water from \$2.41 per 1,000 gallons to \$2.46 per 1,000 gallons.²
- 3. Judy Water proposes to increase the water rates to its customers effective July 1, 2013.
- 4. During the 12 months ending May 31, 2013, Judy Water purchased a total of 148,380,600 gallons of water, 110,560,600 of which were purchased from Mount Sterling, and sold 139,278,000 gallons.

- 5. The increase in the cost of purchased water is \$5,528.03, resulting in a purchased water adjustment factor of \$0.04 per 1,000 gallons.
- 6. The purchased water adjustment of \$0.04 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.
- 7. Judy Water's proposed rates, which are set forth in Appendix B, are fair, just and reasonable.

IT IS THEREFORE ORDERED that:

- 1. Judy Water's proposed purchased water adjustment of \$0.04 per 1,000 gallons is approved for water service rendered on and after July 1, 2013.
 - 2. Judy Water's proposed rates are approved.
- 3. Judy Water's proposed tariff sheet, which was submitted with its application, is approved as filed.
