## ORDER

On February 21, 2011, the Commission granted the request of Assurance Home Phone Services, Inc. ("Assurance Home Phone") for designation as an Eligible Telecommunications Carrier ("ETC"). Assurance Home Phone was authorized only to receive low-income support and not high-cost support. On June 12, 2013, Assurance Home Phone petitioned the Commission for withdrawal of its ETC status. Assurance Home Phone states that it has not provided service in Kentucky and therefore has no customers.

47 USC § 214 (e)(4) states in part:

shall permit eligible commission The state telecommunications carrier to relinquish its designation as such a carrier in any area served by more than one eligible telecommunications carrier. An eligible telecommunications relinguish its to carrier that seeks telecommunications carrier designation for an area served by more than one eligible telecommunications carrier shall give advance notice to the State commission of such relinquishment. Prior to permitting a telecommunications carrier designated as an eligible telecommunications carrier to cease providing universal service in an area served by more than one eligible telecommunications carrier, the State

commission shall require the remaining eligible telecommunications carrier or carriers to ensure that all customers served by the relinquishing carrier will continue to be served, and shall require sufficient notice to permit the purchase or construction of adequate facilities by any remaining eligible telecommunications carrier. The state commission shall establish a time, not to exceed one year after the State commission approves such relinquishment under this paragraph, within which such purchase or construction shall be completed.

The Commission finds that, pursuant to USC 47 § 214(e)(4) above, there is more than one ETC in the area of relinquishment and those carriers have sufficient facilities for the provision of service. Additionally, since Assurance Home Phone has no customers, it is not necessary for the Commission to make a determination on the ability of other ETCs to serve those customers.

The Commission being sufficiently advised, IT IS HEREBY ORDERED that Assurance Home Phone's request to withdraw as an ETC is granted. This case is now closed and removed from the Commission's docket.
