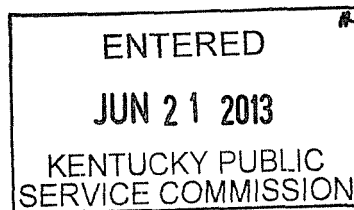

ORDER


