ORDER

On October 10, 1986, in Case No. 9565,¹ the Commission approved rates for Public Gas Company ("Public") and provided for their further adjustment in accordance with Public's Gas Cost Adjustment ("GCA") clause.

On June 26, 2013, Public filed its proposed GCA to be effective August 1, 2013.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Public's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Public's notice sets out an Expected Gas Cost ("EGC") of \$5.7516 per Mcf, which is a decrease of \$.8168 per Mcf from the previous EGC of \$6.5684 per Mcf.
3. Public's notice sets out no current quarter Refund Adjustment.
4. Public's notice sets out a current quarter Actual Adjustment ("AA") of (\$.0328) per Mcf. Public's total AA is \$.0505 per Mcf, which is an increase of \$.3094 per Mcf from the previous total AA of (\$.2589) per Mcf.

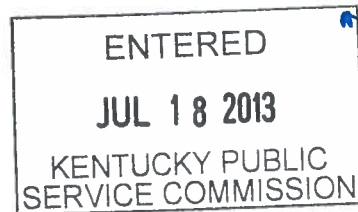
5. Public's GCA is \$5.8021 per Mcf, which is a decrease of \$.5074 per Mcf from the previous GCA of \$6.3095 per Mcf.

6. The rates in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Public on and after August 1, 2013.

IT IS THEREFORE ORDERED that:

1. The rate proposed by Public is approved.
2. The rate in the Appendix attached hereto and incorporated herein is approved for billing for service rendered on and after August 1, 2013.
3. Within 20 days of the date of this Order, Public shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
