#### ORDER

On July 19, 2013 Farmdale Water District ("Farmdale") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Farmdale purchases water from Frankfort Plant Board ("Frankfort").
- 2. On June 28, 2013, Frankfort increased the Kentucky River Authority fee portion of its wholesale water rate to Farmdale from \$0.1079 per 1,000 gallons to \$0.20 per 1,000 gallons.
- 3. During the 12 months ended April 30, 2013, Farmdale purchased 202,434,000 gallons of water from Frankfort and sold 160,066,000 gallons of water. The increase in the cost of purchased water is \$18,644.17, resulting in a purchased water adjustment factor of \$0.12 per 1,000 gallons.
- 4. Farmdale increased its rates for water service effective August 1, 2013 to reflect the increased cost of purchased water.
- 5. Farmdale's proposed rates for water service are fair, just, and reasonable and should be approved for service rendered on or after August 1, 2013.

6. The purchased water adjustment factor of \$0.12 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.

### IT IS THEREFORE ORDERED that:

- 1. The proposed purchased water adjustment factor of \$0.12 per 1,000 gallons is approved.
- 2. Farmdale's proposed rates, which are set forth in Appendix B to this Order, are approved for water service that Farmdale renders on or after August 1, 2013.
- 3. Within 20 days of the date of this Order, Farmdale shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
