### ORDER

On October 2, 2013, Powell's Valley Water District ("Powell's Valley") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Powell's Valley purchases water from Beech Fork Water Commission ("Beech Fork").
- 2. On September 10, 2014, Beech Fork notified Powell's Valley that its wholesale rate to Powell's Valley would increase effective January 1, 2014, from \$2.592 per 1,000 gallons to \$2.732 per 1,000 gallons.
- 3. Powell's Valley proposes to increase the water rates to its customers effective January 1, 2014.
- 4. During the 12 months ending September 30, 2013, Powell's Valley purchased a total of 127,732,600 gallons of water and sold 106,834,320 gallons.
- 5. The increase in the cost of purchased water is \$17,882.56, resulting in a purchased water adjustment factor of \$0.17 per 1,000 gallons.

- 6. The purchased water adjustment of \$0.17 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just and reasonable and should be approved.
- 7. Powell's Valley's proposed rates, which are set forth in Appendix B, are fair, just and reasonable.

#### IT IS THEREFORE ORDERED that:

- 1. Powell's Valley's proposed adjustment of \$0.17 per 1,000 gallons is approved for water service rendered on and after January 1, 2014.
- 2. Powell's Valley's proposed rates are approved for water service rendered on and after January 1, 2014.
- 3. Within 20 days of the date of this Order, Powell's Valley shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
