ORDER

On October 17, 2013, South Hopkins Water District ("South Hopkins") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure¹.

The Commission, having reviewed the record and being sufficiently advised, finds that:

- South Hopkins purchases water from the city of Dawson Springs,
 Kentucky ("Dawson Springs").
- 2. October 1, 2013, Dawson Springs decreased its wholesale water rate to South Hopkins from \$1.73657 per 1,000 gallons to \$1.72570 per 1,000 gallons.
- 3. South Hopkins decreased its water rates to its customers on October 1, 2013 to reflect the change in its cost of purchased water.
- 4. During the 12 months ended July 31, 2013, South Hopkins purchased 309,353,370 gallons of water and sold 256,014,629 gallons. The decrease in the cost of purchased water is \$3,362.67 resulting in a purchased water adjustment of (\$0.01) per 1,000 gallons.

5. The purchased water adjustment of (\$0.01) per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment of (\$0.01) per 1,000 gallons as calculated in Appendix A is approved.
- 2. South Hopkins' proposed rates, which are set forth in Appendix B, are approved for services that South Hopkins renders on or after October 1, 2013.
- 4. Within 20 days of the date of this Order, South Hopkins shall file with the Commission, using the Commission's electronic Tariff Filing System, a revised tariff sheet showing the approved rates.
