

SUPPLEMENTAL RESPONSE TO COMMISSION ORDER**

Taylor County Rural Electric Cooperative Corporation ("Taylor RECC"), acting by counsel, makes the following Response by way of supplementation to its Response herein filed with the Commission on or about May 8, 2014:

1. Subsequent to Taylor RECC's initial Response to the Commission's Order entered herein on April 29, 2014, Taylor RECC's representatives have continued to visit the McAninch property and have, consistent with Mr. McAninch's revised proposal for extended service, made the installation which are deemed necessary.


2. After a brief delay relating to the necessity for proper certified inspection of Mr. McAninch's facilities, Taylor RECC has completed its extension, and Mr. McAninch's facility was energized on Thursday, May 22, 2014.

3. Given the nature of Mr. McAninch's revised proposal, Taylor RECC was not required to, and did not, make any charge for the subject extension of service; and Mr. McAninch's financial obligation will be limited to the cost of metered service.

WHEREFORE, Taylor RECC requests that this be accepted as its supplemental and final Response herein, and that the within proceeding be dismissed as resolved.


