Now comes Jackson Purchase Energy Corporation (“JPEC”) and moves that it be granted full intervention herein. In support of this motion, JPEC state as follows:



2. JPEC is a distribution cooperative and a member of Big Rivers Electric Corporation (“Big Rivers”), the applicant in this proceeding. 
