ORDER

On January 9, 2014, Todd County Water District ("Todd District") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Todd District purchases water from Logan-Todd Regional Water
 Commission ("Logan-Todd").
- 2. Logan-Todd notified Todd District that effective January 1, 2014, Logan-Todd will increase its wholesale water volumetric rate to Todd District from \$3.83 per 1,000 gallons of water to \$3.91 per 1,000 gallons.
- 3. Todd District proposes to adjust its rates effective March 1, 2014, to reflect the increase in its wholesale supplier's rate for wholesale water service.
- 4. During the 12 months ended November 30, 2013, Todd District purchased 193,885,000 gallons of water from Logan-Todd. Todd District sold 157,476,200 gallons of water during the same period.
- 5. The purchased water adjustment factor of \$0.10 per 1,000 gallons of water, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.

6. The rates set forth in Appendix B to this Order are fair, just, and reasonable and should be approved for water service that Todd District renders on and after March 1, 2014.

IT IS THEREFORE ORDERED that:

- 1. Todd District's proposed rates are approved.
- 2. The purchased water adjustment factor of \$0.10 per 1,000 gallons is approved.
- 3. The rates in Appendix B are approved for water service that Todd District renders on or after March 1, 2014.
- 4. Within 20 days of the date of this Order, Todd District shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the approved rates, with an effective date of March 1, 2014.
