ORDER

The Commission, upon its own motion, HEREBY ORDERS that:

1. The procedural schedule set forth in the Appendix, which is attached hereto and incorporated herein, shall be followed.
2. A person who submits a motion to intervene after June 16, 2014, and upon a showing of good cause, is granted full intervention shall accept and abide by the existing procedural schedule.
3. a. Responses to requests for information shall be appropriately bound, tabbed, and indexed and shall include the name of the witness responsible for responding to the questions related to the information provided, with copies to all parties of record and eight copies to the Commission.

b. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

c. Any party shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect.

d. For any request to which a party fails or refuses to furnish all or part of the requested information, that party shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

4. The parties shall consider any request for information from Commission Staff as if ordered by the Commission.

5. Service of any document or pleading in paper form shall be made in accordance with 807 KAR 5:001, Section 4(8).

6. Any party filing a document or pleading with the Commission shall serve such document or pleading upon all other parties to this proceeding.

7. Any document or pleading that a party serves upon the other parties to this proceeding shall also be filed with the Commission.


8. Motions for extensions of time with respect to the procedural schedule shall be made in writing and will be granted only upon a showing of good cause.
