### ORDER

Jackson Energy Cooperative Corporation ("JECC") tendered its application in this matter with the Commission on February 13, 2014. In its application, JECC requested an effective date of March 17, 2014, for its proposed Section EDR, Economic Development Rider ("EDR") tariff. The Commission finds, pursuant to KRS 278.190, further proceedings are necessary in order to determine the reasonableness of the proposed tariff and that such proceedings may not be completed prior to the proposed effective date. In addition, the Commission finds that a procedural schedule should be established to commence a review of the reasonableness of the proposed tariff. That procedural schedule is attached hereto as an Appendix to this Order and is incorporated herein.

#### IT IS THEREFORE ORDERED that:

- 1. JECC's proposed EDR tariff is hereby suspended for five months from March 17, 2014, up to and including August 15, 2014. Nothing shall prevent the Commission from issuing an Order prior to the end of the suspension period.
- 2. The procedural schedule for processing the review of the proposed tariff is attached hereto as an Appendix and shall be followed in this case.

- 3. Any document filed with the Commission shall be served on all parties of record, with ten copies to the Commission.
- 4. All parties shall respond to any interrogatories or requests for production of documents that Commission Staff submits in accordance with the procedural schedule set forth in the Appendix.
- 5. a. Responses to requests for information shall be appropriately bound, tabbed and indexed and shall include the name of the witness responsible for responding to the questions related to the information provided.
- b. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.
- c. Any party shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect.
- d. For any request to which a party fails or refuses to furnish all or part of the requested information, that party shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.
- 6. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.

7. A person who submits a motion to intervene after March 14, 2014, and upon a showing of good cause is granted leave to intervene, shall accept and abide by the existing procedural schedule.
