On May 30, 2014, East Kentucky Power Cooperative (“EKPC”) moved the Commission to schedule an informal conference in this matter. EKPC proposes to discuss the issues that have been raised in requests for information to EKPC and its member cooperatives. EKPC specifically asserts a desire to discuss the effect of the current environmental surcharge and the possibility of a longer amortization period in certain instances wherein there is a significant over- or under-recovery.

The Commission finds that EKPC’s motion for an informal conference should be granted.


IT IS HEREBY ORDERED that:
