## ORDER

On October 21, 2010, in Case No. 2010-00116,<sup>1</sup> the Commission approved rates for Delta Natural Gas Company, Inc. ("Delta") and provided for their further adjustment in accordance with Delta's Gas Cost Adjustment clause.

On March 19, 2014, Delta filed its proposed Gas Cost Recovery ("GCR") rate application to be effective April 23, 2014.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Delta's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Delta's notice sets out an Expected Gas Cost ("EGC") of \$7.4657 per Mcf, which is an increase of \$2.0606 per Mcf from the previous EGC of \$5.4051 per Mcf.
- 3. Delta's notice sets out no current quarter Refund Adjustment ("RA"). Delta's total RA is (\$.0400) per Mcf, which is no change from its previous total RA of (\$.0400) per Mcf.

- 4. Delta's notice sets out a current quarter Actual Adjustment ("AA") of \$1.3687 per Mcf. Delta's total AA is \$2.5794 per Mcf, which is an increase of \$.2263 per Mcf from the previous total AA of \$2.3531 per Mcf.
- 5. Delta's notice sets out a current quarter BA of (\$.1571) per Mcf. Delta's total BA is (\$.1125) per Mcf, which represents a decrease of \$.4805 per Mcf from the previous BA of \$.3680 per Mcf.
- 6. Delta's GCR rate is \$9.8926 per Mcf, which is an increase of \$1.8064 per Mcf from the previous GCR rate of \$8.0862 per Mcf.
- 7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Delta on and after April 23, 2014.

#### IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix to this Order are approved for final meter readings on and after April 23, 2014.
- 2. Within 20 days of the date of this Order, Delta shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
