ORDER

On July 24, 2014, the Commission granted the request of the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention (“AG”) for an extension of time within which to submit his initial requests for information to Cumberland Valley Electric, Inc. (“Cumberland Valley”). Subsequently, on August 20, 2014, Cumberland Valley tendered a motion for an extension of time up to and including August 28, 2014, to respond to both the AG’s and Commission Staff’s Requests for Information. In support, Cumberland Valley states that the information requests are voluminous in nature and an additional week is necessary to adequately address the questions. Accordingly, Cumberland Valley requests the entire procedural schedule be moved back one week.

The Commission finds that Cumberland Valley has demonstrated good cause for an extension of time to respond to the AG’s and Commission Staff’s Second Request for Information. However, the Commission further finds that now, due to multiple extensions of the original procedural schedule, moving the entire procedural schedule back by one week is unnecessary and would unreasonably impede the Commission’s timely resolution of the issues in this matter. Therefore the Commission finds that the

amended procedural schedule attached as an Appendix to this Order should be followed.

The Commission therefore ORDERS that:

1. Cumberland Valley's motion for an extension of time to respond to Commission Staff's Second Request for Information is granted.

2. Cumberland Valley's motion to extend the procedural schedule by one week is denied.

3. The procedural schedule set forth in the Appendix to the Commission's July 24, 2014 Order is hereby amended by the procedural schedule attached as an Appendix to this Order.

4. All other provisions of the Commission's July 10 and July 24, 2014 Orders not in conflict with this Order shall remain in full force and effect.
