ORDER

On July 17, 2012, in Case No. 2011-00364¹ the Commission approved rates for Bluegrass Gas Sales, Inc. ("Bluegrass") and provided for their further adjustment on a quarterly basis in accordance with Bluegrass's purchased gas cost adjustment clause.

On May 30, 2014, Bluegrass filed its proposed Gas Cost Recovery rate ("GCR") application to be effective July 1, 2014.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Bluegrass's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Bluegrass's notice sets out an Expected Gas Cost ("EGC") of \$6.4503 per Mcf, which is a decrease of \$.0510 per Mcf from its previous EGC of \$6.5013 per Mcf.
 - 3. Bluegrass's notice sets out no current quarter Refund Adjustment.
- 4. Bluegrass's notice sets out a current quarter Actual Cost Adjustment ("ACA") of \$.6626 per Mcf. Bluegrass's total ACA is \$.7040 per Mcf, which is an increase of \$.8732 per Mcf from its previous total ACA of (\$.1692) per Mcf.

- 5. Bluegrass's notice sets out a current quarter Balance Adjustment ("BA") of (\$.0451) per Mcf. Bluegrass's total BA is \$.1401 per Mcf, which is a decrease of \$.0393 per Mcf from its previous total BA of \$.1794 per Mcf.
- 6. Bluegrass's GCR is \$7.2944 per Mcf, which is an increase of \$.7829 per Mcf from its previous rate of \$6.5115 per Mcf.
- 7. The rate in the Appendix to this Order is fair, just, and reasonable, and should be approved for service rendered by Bluegrass on and after July 1, 2014.

IT IS THEREFORE ORDERED that:

- 1. The rate in the Appendix to this Order is approved for service rendered on and after July 1, 2014.
- 2. Within 20 days of the date of this Order, Bluegrass shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
