ORDER

On June 27, 2014, the Commission entered an Order in this matter establishing new rates for West Shelby Water District ("West Shelby"). Due to a wholesale rate increase from Louisville Water Company ("LWC"), West Shelby was authorized to increase each of its volumetric rates by \$0.05 per 1,000 gallons.\(^1\) However, Appendix B to the June 27, 2014 Order contained an incorrect rate for the minimum bill for 2-inch meters. Specifically, the rate for the 2-inch meter minimum bill was set forth in Appendix B as \$56.95, whereas the correct rate is \$85.97.\(^2\) Consequently, Appendix B to the June 27, 2014 Order should be corrected as set forth in the Appendix to this Order. Additionally, the Commission finds that West Shelby should send a written notice to each customer served by a 2-inch meter of the corrected rate set forth in the Appendix to this Order.

¹ LWC's wholesale volumetric rate of \$1.75 per 1,000 gallons increased to \$1.80 per 1,000 gallons, while its elevated service area surcharge of \$0.30 per 1,000 gallons remains unchanged.

² The prior existing minimum bill for 2-inch meters was \$85.17 and included water usage of 16,000 gallons. With a \$0.05 per 1,000 gallon increase, the increase is \$0.80, making the new minimum bill \$85.97.

IT IS THEREFORE ORDERED, nunc pro tunc, that:

1. The schedule of rates set forth in Appendix B to the June 27, 2014 Order is corrected to the limited extent that the minimum bill for 2-inch meters shall be \$85.97, as set forth in the Appendix attached to this Order.

2. West Shelby shall send a written notice to each customer served by a 2-inch meter of the corrected rate set forth in the Appendix to this Order.

3. All other provisions of the June 27, 2014 Order shall remain in full force and effect.
