## ORDER

On September 2, 2014, Frankfort Electric and Water Plant Board ("Frankfort Plant Board") filed a motion pursuant to 806 KAR 5:001, Section 22, to deviate from the requirement in the Commission's July 23, 2014 Order to file an original and paper copies of responses to Commission Staff's First Request for Information ("Staff's First Request"). Except for Items 2.c. and 13 of Staff's First Request, Frankfort Plant Board filed an original and six copies of its response to Staff's First Request. Frankfort Plant Board's responses to Items 2.c. and 13 of Staff's First Request were filed on a compact disk ("CD") and Frankfort Plant Board provided six copies of the CD. In response to Item 2.c., Frankfort Plant Board provided a CD containing a copy of the check register. In response to Item 13, Frankfort Plant Board provided a CD containing copies of invoices.

Frankfort Plant Board requests a deviation permitting it to file the responses to Items 2.c. and 13 of Staff's First Request in a CD format. In support of its request for a deviation, Frankfort Plant Board indicates that the response to Item 2.c. consists of

approximately 500 pages and the response to Item 13 consists of approximately 700 pages.<sup>1</sup>

Having considered the motion, the Commission finds that:

- 1. Frankfort Plant Board's motion for a deviation should be granted.
- 2. Frankfort Plant Board's responses to Items 2.c. and 13 of Staff's First Request should be accepted as filed on a CD.

## IT IS THEREFORE ORDERED that:

- 1. Frankfort Plant Board's motion for a deviation is granted.
- 2. Frankfort Plant Board's responses to Items 2.c. and 13 of Staff's First Request are accepted as filed on a CD.
