ORDER

During an informal conference held on September 11, 2014, the parties discussed Frankfort Electric and Water Plant Board's ("Frankfort Plant Board") September 2, 2014 responses to Requests for Information issued on August 19, 2014. Frankfort Plant Board agreed to supplement certain of its September 2, 2014 responses by September 19, 2014.

Based on the procedural schedule set forth in the Commission's Order of August 15, 2014, the next Request for Information is to be issued on September 17, 2014, two days before the Frankfort Plant Board will supplement certain of its September 2, 2014 responses. The Commission, therefore, finds good cause to revise the procedural schedule.

IT IS THEREFORE ORDERED that:

1. The Informal Conference currently scheduled for December 2, 2014, is rescheduled to December 15, 2014.
2. The procedural schedule set forth in the Appendix to this Order shall be followed.
3. All provisions of the August 15, 2014 Order that are not in conflict with the terms of this Order shall remain in effect.
