ORDER

On October 6, 2014, Frankfort Electric and Water Plant Board ("Frankfort Plant Board"), by counsel, filed a motion to suspend the procedural schedule. Pursuant to the Commission's Order entered September 17, 2014, Frankfort Plant Board is to serve its responses no later than October 14, 2014, to requests for information filed by the Intervenors and Commission Staff on October 1, 2014.

To support its request for suspension of the procedural schedule, Frankfort Plant Board indicates that it has reached a settlement agreement with North Shelby Water Company; U.S. 60 Water District of Shelby and Franklin Counties, Kentucky; Elkhorn Water District; Farmdale Water District; Northeast Woodford County Water District; Peaks Mill Water District; and South Anderson Water District. Frankfort Plant Board further states that the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention, is currently reviewing the proposed settlement.

Frankfort Plant Board further requests that the Commission review and approve the settlement agreement and proposed tariff that will be filed in this matter. A copy of the settlement agreement or proposed tariff was not filed with the motion.

Having considered the motion, the Commission finds that:

1. Frankfort Plant Board's request to approve the settlement agreement and proposed tariff should be denied as premature.

2. Frankfort Plant Board's request for a suspension of the procedural schedule should be granted.

IT IS THEREFORE ORDERED that:

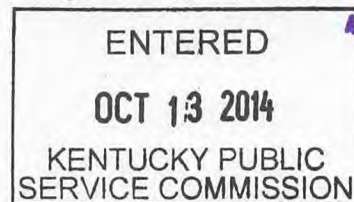
1. Frankfort Plant Board's request to approve the settlement agreement and proposed tariff is denied as premature.

2. Frankfort Plant Board's request to suspend the procedural schedule is granted.

3. The procedural schedule established in the September 17, 2014 Order is suspended for 60 days.

4. Within 60 days of entry of this Order, Frankfort Plant Board shall file the settlement agreement executed by all parties or file responses to the requests for information filed by the Intervenors and Commission Staff on October 1, 2014.
