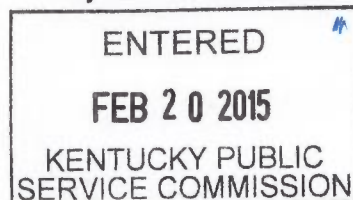

ORDER


