## ORDER

On September 30, 2014, Columbia Gas of Kentucky, Inc. ("Columbia Gas") filed an application seeking to modify and extend its existing Gas Cost Incentive Mechanism and Off-System Sales and Capacity Release Revenue Sharing Mechanism. On November 20, 2014, Commission Staff issued its Initial Request for Information ("Staff's Initial Request") to Columbia Gas. Columbia Gas was required to file responses to those discovery requests within 14 days of the date of issuance of Staff's Initial Request, or no later than December 4, 2014.

On December 5, 2014, Columbia Gas submitted a motion for a one-day extension within which to respond to Staff's Initial Request. In support of its request, Columbia Gas states that key personnel were out of the office during the two-week response period, and that it worked diligently during that time to respond to Commission Staff's request until those individuals were able to provide responses. Additionally, Columbia Gas states it "was and is committed to Staff's response time and anticipates not requiring any additional extensions for vacations or holidays during this

proceeding."

Columbia Gas attached to its motion its responses to Staff's Initial Request.

The Commission, having considered Columbia Gas's motion and being otherwise sufficiently advised, finds that Columbia Gas has demonstrated good cause to grant a one-day extension to respond to Staff's Initial Request.

IT IS THEREFORE ORDERED that Columbia Gas's motion for a one-day extension is granted.
