ORDER

On November 18, 2014, Farmdale Water District ("Farmdale") submitted an application for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Farmdale purchases water from the Frankfort Electric & Water Plant Board ("Frankfort").
- 2. On November 12, 2014, Frankfort increased its wholesale water rate to Farmdale from \$2.01 per 1,000 gallons to \$2.25 per 1,000 gallons.² Farmdale proposed to increase its water rates to reflect the increased cost of purchased water effective December 1, 2014.
- 3. During the 12 months ended August 31, 2014, Farmdale purchased 231,762,000 gallons of water from Frankfort and sold 170,496,000 gallons of water

during the same 12 months. The increase in the cost of purchased water is \$55,622.88, resulting in a purchased water adjustment factor of \$0.32 per 1,000 gallons.

- 4. The purchased water adjustment of \$0.32 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.
- 5. Farmdale's proposed rates, as set forth in Appendix B to this Order, are fair, just, and reasonable and should be approved for water service rendered on and after December 1, 2014.

IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment of \$0.32 per 1,000 gallons is approved.
- Farmdale's proposed rates are approved for service rendered on or after
 December 1, 2014.
- 3. Within 20 days of the date of this Order, Farmdale shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
