Re: Cannonsburg Water District's Unaccounted-For Water Loss Reduction Plan,
Surcharge and Monitoring
Case No. 2014-00267

Dear Mr. Sinnette:

On June 17, 2015, Cannonsburg Water District filed three monthly reports: a surcharge report; a monthly water loss report; and a surcharge monthly activity report. Within the surcharge monthly activity report, Cannonsburg Water District requests authority to use funds from the surcharge account to replace five large customer meters at a cost of \$6,000 each.

The surcharge account was established in Case No. 2011-00217 with the restriction that the funds be withdrawn only for expenditures related to Cannonsburg Water District's unaccounted-for water loss reduction plan. Subsequently, on August 7, 2014, in Case No. 2014-00267, the Commission approved a water loss detection plan for Cannonsburg Water District, authorized the expenditure of \$133,562 from the surcharge account, and specifically stated as follows:

7. Cannonsburg District shall not spend any funds beyond those authorized herein from the separate interest-bearing surcharge account until further Order of this Commission.

Thus, Cannonsburg Water District's June 17, 2015 request is in the nature of a motion seeking an Order from the Commission authorizing the expenditure of additional funds from the surcharge account for the replacement of five large customer meters.

Our records indicate that you are currently the attorney of record for Cannonsburg Water District. If you are still representing Cannonsburg Water District in this matter, the Commission cannot take any action on Cannonsburg Water District's

request until you file a motion on the water district's behalf. If you are no longer representing Cannonsburg Water District in this matter, please submit a written notice of your withdrawal of representation of Cannonsburg Water District.
