ORDER

On October 31, 2008, in Case No. 2008-00032,¹ the Commission approved rates for Burkesville Gas Company, Inc. (“Burkesville”) and provided for their further adjustment on a monthly basis in accordance with Burkesville’s Purchased Gas Cost Adjustment (“GCA”) clause. On June 1, 2013, Burkesville implemented a revision in its GCA clause to provide for quarterly adjustment of its rates.

On August 24, 2015, Burkesville filed its Gas Cost Recovery (“GCR”) rate application with a proposed effective date of September 28, 2015.

After reviewing the evidence of record and being otherwise sufficiently advised, the Commission finds that:

1. Burkesville’s notice includes revised rates designed to pass on to its customers its expected change in gas costs.
2. Burkesville’s proposed Expected Gas Cost (“EGC”) is \$8.0041 per Mcf, which is an increase of \$.0533 per Mcf from the prior EGC of \$7.9508 per Mcf.
3. Burkesville’s notice sets out no Refund Adjustment.

4. Burkesville's notice sets out a current Actual Cost Adjustment ("ACA") of (\$.0940) per Mcf. Burkesville's total ACA is (\$.7341) per Mcf, which is an increase of \$.1396 per Mcf from its previous total ACA of (\$.8737) per Mcf.

5. Burkesville's notice sets out a GCR rate of \$7.2700, which is an increase of \$.1929 per Mcf from the previous GCR rate of \$7.0771 per Mcf.

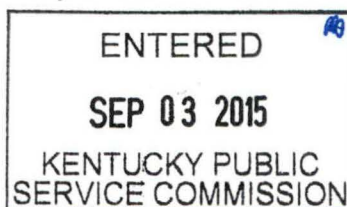
6. The rates as proposed by Burkesville and set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Burkesville on and after September 28, 2015.

IT IS THEREFORE ORDERED that:


1. The rates proposed by Burkesville and set forth in the Appendix to this Order are approved for service rendered on and after September 28, 2015.

2. Within 20 days of the date of this Order, Burkesville shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
