MOTION TO POSTPONE SCHEDULED HEARING

Pam Carpenter, Jerry Fields, Larry Redden, and David French (“Respondents”) move that the Commission postpone the hearing scheduled in this matter for August 25, 2015 pending a ruling on the Respondents’ Motion to Accept Offer of Settlement.


In support of their motion, the Respondents state that they have filed with the Commission an Offer of Settlement to resolve this proceeding. Should the Commission accept this Offer, the scheduled hearing will not be necessary as the Respondents have agreed to waive their right to a hearing. It will eliminate the need for Commission Staff and the Respondents to continue preparations for the scheduled hearing, which may not be required, while awaiting the Commission’s ruling on the motion. Postponement of the hearing will also allow the Commission adequate time to review the Offer and to prepare its decision.

The Respondents further state that, in addition to this motion, they have also moved in a separate pleading for disclosure of the evidence that the Commission intends to introduce at the scheduled hearing. As part of that other motion, the Respondents have also requested a

postponement of the scheduled hear to allow them adequate time to review the disclosed evidence should the Commission grant their motion.
