Mr. Wuetcher:

Regarding your request, per KRS 278.990, an officer, agent or employee of a utility can be subject to penalties for violations. The Commission's June 9, 2015 Order speaks for itself. The Commission considered the evidence set forth in Case No. 2014-00421 and made findings as set forth in the June 9, 2015 Order in this case, that a prima facie case had been made that the General Manager and the Water Commissioners had violated KRS 278.300. As counsel for the Commission, I cannot supplement the Commission's findings. The purpose of scheduling a hearing on August 25, 2015 is to provide an opportunity for the Respondents to present their positions as to why they should not be subject to penalties. If the General Manager does not believe he has taken any actions "to aid and abet the alleged willful violation of KRS 278.300", he can appear on August 25, 2015 and present his position.
