## NOTICE BY B&H GAS COMPANY AND B&S OIL AND GAS COMPANY OF STATUS OF FILING ARF AND STATUS OF FILING RESPONSES TO AG'S DATA REQUESTS

Comes B&H Gas Company ("B&H"), and B&S Oil and Gas Company ("B&S"), by and through counsel, and hereby provide the following notice to the Commission and to the Attorney General of the status of the ARF filing for B&H, and the status of filing responses to the data requests served by the Attorney General.

In its joint motion to hold this case in abeyance, filed January 29, 2016, B&H and B&S informed the Commission that it was its intent to file an ARF on behalf of B&H by April 10, 2016. However, the accountant charged with preparing B&H's financials for the 2015 calendar year has not been able to provide the information to B&H as of the date of this filing. Without this information, it is impossible for B&H to properly prepare the ARF and the many attachments which must accompany the alternative rate filing. Upon receipt of the information from the accountant, which is expected no later than April 30, 2016, the ARF should be ready to file within ten (10) days thereafter.

In addition, answering the AG's extensive data requests, as more particularly set forth in the response filed by B&H and B&S to the AG's motion for a procedural schedule, has been very time consuming and has taxed the resources of B&H and B&S, which are very small companies. It is expected that the responses will be ready for service and filing on or before April 18, 2016.
