NOTICE TO THE CUSTOMERS OF WOOD CREEK WATER DISTRICT

On January 15, 2016, in Case No. 2015-00428, Wood Creek Water District ("Wood Creek") applied to the Kentucky Public Service Commission ("PSC") for authority to increase its rates for water service by 14.53 percent. After performing a review of Wood Creek's application and records, the PSC Staff found that Wood Creek's test-year operations support a 17.07 percent water rate increase and a 72.18 percent sewer rate increase. As allowed by the PSC's Order dated February 2, 2016, Wood Creek requested that the PSC allow it to increase its monthly water service rates by 17.07 percent and to increase its monthly sewer service rates by 17.07 percent. A comparison of Wood Creek's current and requested water and sewer service rates is provided below:

If the Commission does not receive any objections or requests for intervention establishing the grounds for the request including the status and interest of the party or requests for hearing in this matter within thirty (30) days of initial publication or mailing of the notice, the commission may take final action on the application and shall proceed to render a decision in the matter.
