COMMISSION STAFF'S SECOND REQUEST FOR INFORMATION
TO FLEMING-MASON ENERGY COOPERATIVE, INC.

Fleming-Mason Energy Cooperative, Inc. ("Fleming-Mason"), pursuant to 807 KAR 5:001, is to file with the Commission the original and seven copies of the following information, with a copy to all parties of record. The information requested herein is due within ten days of the date of this request. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Fleming-Mason shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though

correct when made, is now incorrect in any material respect. For any request to which Fleming-Mason fails or refuses to furnish all or part of the requested information, it shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.


Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Fleming-Mason shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Refer to Fleming-Mason's response to Commission Staff's February 6, 2017 Request for Information, Item 5, page 43 of 43.

a. Confirm that International Paper is billed for electric service at East Kentucky Power Cooperative, Inc.'s ("EKPC") Rate Schedule G. If this cannot be confirmed, state the EKPC rate under which International Paper is billed.

b. If the Commission requires a change in EKPC's base fuel rate, EKPC is proposing a Schedule G energy rate of \$.038467. Fleming-Mason is proposing an energy rate to International Paper of \$.04047, a difference of \$.002003 from the EKPC rate. State whether this difference represents the retail mark-up billed by Fleming-Mason which is added to the EKPC rate. If not, explain the difference.

c. If the Commission requires a change in EKPC's base fuel rate, EKPC is proposing an International Paper steam energy rate of \$4.318/mmbtu. Fleming-Mason is proposing an International Paper steam energy rate of \$4.554/mmbtu. Explain the difference between Fleming-Mason's and EKPC's proposed steam energy rate.
