### ORDER

KRS 278.230(3) directs every utility, when required by the Commission, to file with it any report or other information that the Commission reasonably requires. 807 KAR 5:006, Section 4(2), requires every utility to file with the Commission, on or before March 31 of each year, a financial and statistical report of its utility operations for the preceding calendar year on forms furnished by the Commission. KRS 278.140 requires each utility to file, on or before March 31 of each year, a report of its gross earnings or receipts derived from intrastate business for the preceding calendar year. KRS 278.990 provides penalties for utilities that fail to file the required reports.

Center Ridge Water District No. 2 ("Center Ridge") owns, controls, operates, and manages facilities in the Commonwealth of Kentucky which are used for and in connection with the distribution and furnishing of water to the public for compensation. It is, therefore, a utility subject to Commission jurisdiction.<sup>1</sup>

KRS 278.990(1) states that any utility which willfully violates any provision of KRS Chapter 278 or any Commission regulation shall be subject to a civil penalty not less than \$25.00 and not more than \$2,500.00.

On January 13, 2016, the Commission provided to Center Ridge an electronic link to the standard forms for the annual financial and statistical report and the report of gross earnings from intrastate business. According to Commission records, Center Ridge filed its annual report and gross operating report for the 2015 calendar year on or about January 10, 2017. The failure to file these reports by March 31, 2016, is *prima facie* evidence that Center Ridge willfully failed to comply with KRS 278.230(3).

The Commission initiated a similar action against Center Ridge on October 11, 2011, for failing to file its annual report for the 2010 calendar year.<sup>2</sup> In Case No. 2011-00337, the Commission, after a hearing at which Center Ridge did not appear, assessed Center Ridge a penalty of \$2,500.00.<sup>3</sup> On October 3, 2012, the Commission issued an Order<sup>4</sup> suspending the payment of the fine, contingent upon Center Ridge's timely filing of its 2012, 2013, 2014, 2015, and 2016 annual reports. The October 3, 2012 Order provided that the fine would be waived upon the timely filing of the 2016 annual report, but also provided that the fine would become due and payable if Center Ridge did not timely file its 2012, 2013, 2014, 2015, and 2016 annual reports. It appears that by not timely filing its 2015 annual report, Center Ridge violated the Commission's October 3, 2012 Order issued in Case No. 2011-00337 and, consequently, the suspended fine of \$2,500.00 is due and payable.



#### ORDER

On October 11, 2011, the Commission ordered Center Ridge Water District No. 2 ("Center Ridge") to show cause why it should not be penalized for failing to comply with KRS 278.230(3). The October 11, 2011 Order scheduled a formal hearing and also provided that Center Ridge could waive its right to a hearing if it filed its annual report and paid a \$250.00 penalty by October 20, 2011. Center Ridge neither filed its annual report nor paid the \$250.00 fine by October 20, 2012. A hearing in this matter was held on October 27, 2011. No representative appeared on behalf of Center Ridge.

On December 9, 2011, Center Ridge filed its 2010 annual report. The report was unaccompanied by any explanation why the annual report was filed late. There also was no explanation why Center Ridge failed to appear at the October 27, 2011 hearing or pay the \$250.00 fine by October 20, 2011.

On December 20, 2011, the Commission issued an Order in which it found that, even though Center Ridge had filed its 2010 annual report on December 9, 2011, it had willfully violated KRS 278.230 and 807 KAR 5:006, Section 3(1). The Commission assessed Center Ridge a fine of \$2,500.00 and ordered Center Ridge to pay the fine within fourteen days of the Order. Center Ridge neither sought reconsideration of the Order nor paid the assessed fine. On May 23, 2012, the Commission received a letter<sup>1</sup> from William Duncan, Center Ridge's Operator. In the letter, Mr. Duncan asserts that the failure to timely file Center Ridge's 2010 annual report was merely an oversight on Center Ridge's part but provided no explanation why it did not pay this \$250.00 fine or appear at the October 27, 2011 hearing. Mr. Duncan also asserts that Center Ridge cannot afford to pay the \$2,500.00 fine.

The Commission takes seriously violations of it statutes and regulations and does not lightly grant pardon from the willful violations of these laws. Center Ridge, however, did finally file its 2010 report, albeit in an untimely manner, and has timely filed its 2011 annual report. Because Center Ridge did make its required filings, and because of Center Ridge's alleged inability to pay the \$2,500.00 fine, the Commission finds that the fine shall be suspended indefinitely contingent upon Center Ridge continuing to make timely filings of its annual reports in the future.

IT IS THEREFORE ORDERED that:

 The \$2,500.00 fine imposed against Center Ridge on December 20, 2011 is hereby suspended.

2. If Center Ridge fails to timely file its 2012, 2013, 2014, 2015, or 2016 annual reports in the future, the suspended fine shall no longer be suspended and will become due and payable upon the day after the deadline for filing annual reports.

3. If Center Ridge timely files its 2012, 2013, 2014, 2015, and 2016 annual reports, the \$2,500.00 fine will be waived upon the timely filing of the 2016 annual report.
