The Commission, being otherwise sufficiently advised, finds that the motion should be granted.

IT IS HEREBY ORDERED that:


1. The motion of Kentucky Power to intervene is granted.
2. Kentucky Power shall be entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.
3. Kentucky Power shall comply with all provisions of the Commission's regulation, 807 KAR 5:001, Section 7, related to the service and filing of documents.

4. Within seven days of entry of this Order, Kentucky Power shall provide its electronic mail address to which all electronic documents issued by the Commission and other parties of record may be served upon Kentucky Power in accordance with 807 KAR 5:001, Section 4(8)(b).
