## ORDER

Kentucky American Water Company ("KAWC") is hereby notified that it has been named as defendant in a formal complaint ("Complaint") filed on November 30, 2017, a copy of which is attached hereto. The Complaint, filed by Gerald T. Kemper, discusses the closing of the KAWC Office in Owenton, Kentucky. Mr. Kemper alleges that there is an oral agreement between the city of Owenton and KAWC that allows Owenton to collect utility bills for KAWC for a fee of two dollars per month per bill. Mr. Kemper does not cite in his complaint any statutes or regulations that he claims are being violated, nor does he point to any provisions of the KAWC tariff that are not being followed. Nor does Mr. Kemper ask for any specific relief in his complaint.

Based on a review of the Complaint and being otherwise sufficiently advised, the Commission finds that there is insufficient information to determine whether Mr. Kemper has presented a *prima facie* case. The Commission finds that, in order to assist the Commission in determining whether the Complaint should move forward, Mr. Kemper

should file a more detailed and definitive pleading, including any statutes, regulations or

tariff provisions which are not being followed and any specific relief he is requesting.

Upon Mr. Kemper's filing of this supplemental pleading, the Commission will determine

the next action.

Based on the foregoing, IT IS HEREBY ORDERED that:

1. Within ten days of the date of service of this Order, Mr. Kemper shall file a

more detailed and definitive pleading citing to any statutes, regulations, or tariff provisions

he believes are being violated, and any specific relief he is requesting.

2. A party filing a paper containing personal information shall, in accordance

with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal

information cannot be read.

3. Documents of any kind filed with the Commission in the course of this

proceeding shall also be served on all parties of record.
