ORDER

The matter is before the Commission upon a motion filed on February 27, 2018, by Estill County Water District No. 1 (“Estill District”), requesting an Order to amend and correct factual errors contained in the February 20, 2018 Order denying two motions in this matter. Estill District stated that Estill District’s Commissioners were not identified as parties to the motion to dismiss the hearing, and Estill District was incorrectly identified as a party to the Estill District Commissioners’ motion to dismiss the commissioners as parties. Estill District’s Commissioners William Beard, Greg Wright, and Jerry Arnold (“Estill District Commissioners”) joined Estill District in filing the motion to dispense with hearing. Additionally, Estill District did not join the Commissioners in filing a motion to dismiss the Commissioners as parties to the proceeding.

The Commission finds that Estill District’s motion to amend and correct should be granted. Ordering paragraph 1 of the Commission’s February 20, 2018 Order should read “Estill District and Estill District’s Commissioners’ Motion to Dispense with Evidentiary Hearing and Submit Case for Decision is denied.” Ordering paragraph 2

of the Commission's February 20, 2018 Order should read "Estill District's Commissioners' Motion to Dismiss Commissioners as Parties to Proceeding is denied."

IT IS THEREFORE ORDERED that:

1. Estill District's February 27, 2018 Motion to Amend and Correct the Commission's Order of February 20, 2018 is granted.

2. Ordering paragraph 1 of the Commission's February 20, 2018 Order is amended to read:

Estill District and Estill District's Commissioners' Motion to Dispense with Evidentiary Hearing and Submit Case for Decision is denied.

3. Ordering paragraph 2 of the Commission's February 20, 2018 Order is amended to read:


Estill District's Commissioners' Motion to Dismiss Commissioners as Parties to Proceeding is denied.
