Dear Valued Customers,

The Public Service Commission is attempting to discontinue the natural gas service that The Gas Group, Inc. is providing each of you. In fact the Public Service Commission has issued an Order requiring that the Gas Group enter upon your private property and disconnect the gas service. This includes removing the gas meter, the risers and the gas line. The Gas Group is contesting this. The Gas Group asks that you sign this Petition if:

- a) you rely upon the natural gas service that the Gas Group provides and have no meaningful alternative;
- b) you have received natural gas in a safe, efficient manner at a reasonable price for many years;
- c) you oppose the disconnection of your gas service or any interruption in the gas service that the Gas Group provides;
- d) you oppose any person or entity entering upon your private property and in any way interfering with your property or your gas service.

In addition to signing this Petition a hearing before the Public Service Commission is presently scheduled for 8-9-17 at 9:00 a.m. in Hearing Room 1.
