ORDER

On May 20, 2002, Natural Energy Utility Corporation (“Natural Energy”) adopted the tariffs, including a Purchased Gas Cost Adjustment Clause,¹ for furnishing gas service to the customers previously served by American Natural Gas Corporation.

On February 19, 2018, Natural Energy filed its Gas Cost Recovery (“GCR”) rate application to become effective April 1, 2018.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Natural Energy’s notice includes a revised rate designed to pass on to its customers its expected change in gas costs.
2. Natural Energy’s notice sets out an Expected Gas Cost (“EGC”) of \$4.1884 per Mcf, which is an increase of \$.8072 per Mcf from the previous EGC of \$3.3812 per Mcf.
3. Natural Energy’s notice sets out no Refund Adjustment.
4. Natural Energy’s notice sets out a current quarter Actual Cost Adjustment (“ACA”) of (\$.2629) per Mcf. Natural Energy’s total ACA is (\$.6749) per Mcf, which is a decrease of \$.1664 per Mcf from the previous total ACA of (\$.5085) per Mcf.

5. Natural Energy's GCR rate is \$3.5135 per Mcf, which is an increase of \$.6408 per Mcf from the previous GCR rate of \$2.8727 per Mcf.

6. The rate proposed by Natural Energy and set forth in the Appendix to this Order is fair, just, and reasonable and should be approved for service rendered by Natural Energy on and after April 1, 2018.

IT IS THEREFORE ORDERED that:

1. The rate proposed by Natural Energy and set forth in the Appendix to this Order is approved for service rendered by Natural Energy on and after April 1, 2018.

2. Within 20 days of the date of entry of this Order, Natural Energy shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rate approved herein and reflecting that it was approved pursuant to this Order.
