ORDER

On October 21, 2010, in Case No. 2010-00116,¹ the Commission approved rates for Delta Natural Gas Company, Inc. (“Delta”) and provided for their further adjustment in accordance with Delta’s Gas Cost Adjustment clause.

On March 23, 2018, Delta filed its proposed Gas Cost Recovery (“GCR”) application to be effective April 23, 2018.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Delta’s notice includes revised rates designed to pass on to its customers its expected change in gas costs.
2. Delta’s notice sets out an Expected Gas Cost (“EGC”) of \$5.3116 per Mcf, which is an increase of \$1.2976 per Mcf from the previous EGC of \$4.0140 per Mcf.
3. Delta’s notice sets out no Refund Adjustment.
4. Delta’s notice sets out a current quarter Actual Adjustment (“AA”) of \$.8198 per Mcf. Delta’s total AA is \$1.1796 per Mcf, which is a decrease of \$.0054 per Mcf from the previous total AA of \$1.1850 per Mcf.

5. Delta's notice sets out a current quarter Balance Adjustment ("BA") of (\$.0073) per Mcf. Delta's total BA is \$.0763 per Mcf, which is a decrease of \$.0567 per Mcf from the previous BA of \$.1330 per Mcf.

6. Delta's GCR rate is \$6.5675 per Mcf, which is an increase of \$1.2355 per Mcf from the previous GCR rate of \$5.3320 per Mcf.

7. The rates as proposed by Delta and set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for final meter readings by Delta on and after April 23, 2018.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Delta and set forth in the Appendix to this Order are approved for final meter readings on and after April 23, 2018.

2. Within 20 days of the date of entry of this Order, Delta shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
