ORDER

On June 8, 2018, Northeast Woodford County Water District ("Northeast Woodford District") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Northeast Woodford District purchases water from the Frankfort Electric and Water Plant Board ("Frankfort") and Versailles Municipal Utilities ("Versailles").
- 2. Versailles notified Northeast Woodford District that its wholesale rate would increase from \$2.33 per 1,000 gallons to \$2.42 per 1,000 gallons effective July 1, 2018.²

 Northeast Woodford District proposed to increase the water rates to its customers effective July 1, 2018, to reflect the increased cost of purchased water from Versailles.
- Northeast Woodford District proposed a purchased water adjustment factor of \$0.07 per 1,000 gallons in its application.

- 4. During the 12 months ended April 30, 2018, Northeast Woodford District purchased 44,987,000 gallons of water from Mt. Sterling, and 95,311,100 gallons of water from Versailles. During the same period, Northeast Woodford District sold 134,826,500 gallons of water. The increase in the cost of purchased water is \$8,578.00 resulting in a purchased water adjustment factor of \$0.07 per 1,000 gallons.
- 5. The purchased water adjustment factor of \$0.07 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.
- 6. In its application, Northeast Woodford District incorrectly applied the purchased water adjustment factor to the minimum bill for its two-inch meter rate.
 - 7. Northeast Woodford District's proposed rates are denied.
- 8. The rates as set forth in Appendix B to this Order are fair, just and reasonable, and should be approved for water service rendered by Northeast Woodford District on and after July 1, 2018.

IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment factor of \$0.07 per 1,000 gallons is approved.
 - 2. The rates proposed by Northeast Woodford District are denied.
- 3. The rates set forth in Appendix B to this Order are approved for water service rendered by Northeast Woodford District on and after July 1, 2018.
- 4. Within 20 days of the date of entry of this Order, Northeast Woodford District shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
