ORDER

On August 24, 2018, Bluegrass Gas Sales, Inc. (Bluegrass), filed its proposed Gas Cost Recovery (GCR) rate application to be effective October 1, 2018. After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Bluegrass's application includes revised rates designed to pass on to its customers its expected change in gas costs.
2. Bluegrass's application sets out an Expected Gas Cost (EGC) of \$4.6643 per Mcf.
3. Bluegrass's application sets out no Refund Adjustment.
4. Bluegrass's application sets out a current quarter Actual Cost Adjustment (ACA) of (\$.0254) per Mcf and a total ACA of (\$.2109) per Mcf.
5. Bluegrass's application sets out a current quarter Balance Adjustment (BA) of (\$.0329) per Mcf and a total BA of (\$.0423) per Mcf.
6. Bluegrass's GCR rate is \$4.4111 per Mcf, which is a decrease of \$.0055 per Mcf from its previous GCR rate of \$4.4166 per Mcf.

7. The rate as proposed by Bluegrass and set forth in the Appendix to this Order is fair, just, and reasonable and should be approved for service rendered by Bluegrass on and after October 1, 2018.

IT IS THEREFORE ORDERED that:

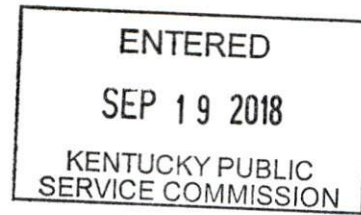
1. The rate proposed by Bluegrass and set forth in the Appendix to this Order is approved for service rendered on and after October 1, 2018.

2. Within 20 days of the date of entry of this Order, Bluegrass shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rate approved herein and reflecting that it was approved pursuant to this Order.

3. This case is closed and removed from the Commission's docket.
