COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION TO  
APACHE GAS TRANSMISSION COMPANY, INC.

Apache Gas Transmission Company, Inc. (Apache), pursuant to 807 KAR 5:001, is to file with the Commission an original and four copies of the following information. The information requested herein is due no later than April 19, 2019. Responses to requests for information in paper medium shall be appropriately bound, tabbed, and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Apache shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Apache fails or refuses to furnish all or part of the requested information, it shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.


Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Apache shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Explain if the Marrowbone pipeline replacement cost will be aggregated into the total pipeline replacement project (PRP) surcharge amount or if Apache will have to get another loan to cover the cost associated with the additional project.
2. Provide all amounts paid to date and supporting invoices for the Marrowbone Creek project.
3. Refer to Case No. 2018-00106.<sup>1</sup> Exhibit A estimates that the annual PRP revenue has a times coverage of 1.02 for the debt service. Provide an explanation of
