ORDER

On April 1, 2019, Kentucky Frontier Gas, LLC (Kentucky Frontier), filed its Gas Cost Recovery (GCR) rate report for rates effective May 1, 2019.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Kentucky Frontier's report includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Kentucky Frontier's report sets out an Expected Gas Cost (EGC) of \$5.0693 per Mcf, which is a decrease of \$.7552 per Mcf from its previous EGC of \$5.8245 per Mcf.
3. Kentucky Frontier's report sets out no Refund Adjustment.
4. Kentucky Frontier's report sets out a current quarter Actual Adjustment (AA) of \$.4879 and a total AA of \$.2883 per Mcf, which is an increase of \$.4879 per Mcf from the previous total AA of (\$.1996) per Mcf.
5. Kentucky Frontier's Balance Adjustment will continue to be unavailable until it files its GCR rate report for rates effective November 1, 2019.
6. Kentucky Frontier's GCR rate is \$.53576 per Ccf or \$5.3576 per Mcf, which is a decrease of \$.2673 per Mcf from its previous rate of \$5.6249 per Mcf.

7. Beginning with the May 1, 2019 billing cycle and going forward, Kentucky Frontier is no longer to include the gas cost reconciliation rates to the GCR rates in the Kentucky Frontier and Public Gas Company's service areas as previously approved in the Final Order in Case No. 2018-00119.<sup>1</sup> Kentucky Frontier should charge both service areas the single system unified GCR rate.

8. The rates as set forth in the Appendix to this Order are fair, just, and reasonable, and should be approved for service rendered by Kentucky Frontier on and after May 1, 2019.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Kentucky Frontier and set forth in the Appendix to this Order are approved for final meter readings by Kentucky Frontier on and after May 1, 2019.

2. Kentucky Frontier's future GCR reports shall follow the information required in finding paragraph 7.

3. Within 20 days of the date of entry of this Order, Kentucky Frontier shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.

4. This case is closed and removed from the Commission's docket.
