ORDER

On February 21, 2020, Letcher County Water and Sewer District (Letcher District) filed its motion for Rehearing (Motion). Letcher District argued that the Commission's findings in the January 31, 2020 final Order regarding Knott County Water and Sewer District's (Knott District) health insurance expense conflicted with the evidence in the record.¹ Letcher District also argued that the Commission's findings regarding the level of Knott District's reasonable employee health insurance expense and health insurance waiver credit expense is inconsistent with prior Commission decisions and should be modified to conform with those decisions.² On February 28, 2020, Knott District responded to Letcher District's Motion. Knott District argued that Letcher District's Motion was not timely filed and should be dismissed.³ Knott District further contended that the Commission's findings regarding the level of health insurance expense did not conflict with evidence in the record and that the Commission's decision did not conflict with prior

Commission decisions.⁴ On March 2, 2020, Letcher District filed its Notice of Withdrawal of Motion for Rehearing (Notice). In the Notice, Letcher District advised the Commission that it was withdrawing its February 21, 2020 motion requesting a rehearing of the Commission's January 31, 2020 Order. The Commission will treat the Notice as a motion.⁵

After consideration of the evidence of record and being otherwise sufficiently advised, the Commission finds that Letcher District's Notice should be granted.

IT IS THEREFORE ORDERED that Letcher District's Notice of Withdrawal of Motion for Rehearing is granted.


