ORDER

On February 27, 2020, the Commission ordered Push Underground Construction LLC (Push Underground), to submit a written response within 20 days of receipt of the Commission's Order, to the allegations contained in the Staff Incident Reports for Incident Numbers 31649, 32084, and 32255, which were attached as an Appendix to the Commission's Order.

On March 30, 2020, the Commission received a check in the amount of \$7,250 for payment of Incident Numbers 31649, 32084, and 32255. A copy of the receipt for that payment is attached to this Order as an Appendix.

The Commission finds that Push Underground has addressed to its satisfaction the probable violations cited by Staff in the Incident Reports. The Commission further finds the Commission's investigation of this incident should be closed.

IT IS THEREFORE ORDERED that:

1. Push Underground's payment of Staff's proposed penalty is accepted and resolves the alleged violations that were the subject of the Incident Reports.

2. Push Underground's payment of Staff's proposed penalty is not an admission by Push Underground that it violated any provision of KRS Chapter 367 or any administrative regulation promulgated pursuant thereto.

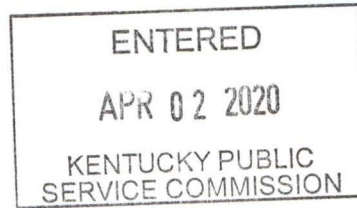
3. The Commission's investigation of these incidents is closed.
